MAKE YOUR VOTE COUNT

For CVT to validate ballots associated with special or annual membership meetings, the signature on the ballot return envelope must match the signature on that member's account. For businesses, this means that the person signing is listed on your membership card (do not sign with your business name!). For residential accounts, the person signing must be listed on the account name/ membership card and have a valid signature on file with CVT.

Important: being an authorized person on a residential account does not mean that you are listed on the membership record. For example, if an account name is listed as "John and Jane Smith" this is a joint account and either person may sign the ballot return envelope. If an account is listed as "John Smith" and Jane is listed as an authorized person, this does not give Jane the ability to vote on behalf of the account.

Copper Valley Telecom is happy to announce our scholarship applications are now available for the 2020 year. Copper Valley Telecom is giving out \$20,000 in scholarships to eligible, high school seniors. CVT also promotes scholarships from The Foundation for Rural Services (FRS) and The Alaska Telephone Association (ATA). The deadline for completed CVT scholarship applications is March 13th, 2020.
